The Aesthetics Membership Plan is not an insurance plan and is not intended to act as or replace insurance. For an annual charge, our Aesthetics Membership Plan will allow you to obtain many aesthetic services at no charge and significant discounts on other services.

#### MEMBERSHIP TERMS

This is an in-house Aesthetics Membership Plan that is only valid at CA’s office. It cannot be used at any other location and it cannot be combined with any insurance. Membership fees must be paid prior to the first exam or scheduled treatment and may not be rendered using a third-party gift card, e.g. Visa Mastercard or American Express. Benefit period begins on the date the membership payment is rendered, and will continue for twelve (12) or six (6) months from that date. Members opting for a six (6) month term are permitted to upgrade to a twelve (12) month term for an additional charge of \$150.00. This will extend the membership for the remaining six (6) months of that twelve (12) month period. This offer stands but will not necessarily be initiated by CA; the member should expect to be responsible for the upcoming conclusion of their membership term and act to renew or upgrade accordingly.

Payment in full for any treatments rendered under the Aesthetics Membership Plan must be made at the time of treatment. Extended payment plans, including third party financing plans, may not be used in conjunction with this Aesthetics Membership Plan. There may be a charge assessed for any missed appointments or appointments canceled without 24 hours’ notice, which is not covered under the Aesthetics Membership Plan.

Benefits cannot be redeemed for cash or store credit. Benefits not used during the membership period will not transfer to a future membership period, if renewed. Benefits are non-transferrable to another client. Memberships can be gifted to an individual one-time and must be named at time of purchase. In the event of relocation, the member may cancel in accordance with the

cancellation policy as set forth in their contract. In the event of death, the executor of the estate of the member may cancel in accordance with the cancellation policy as set forth in the member's contract. Membership cost and benefits subject to change at any time; all existing contracts will be honored through the end of the membership term. CA reserves the right to cancel or discontinue this plan for any reason at the end of the membership term. Renewals are not automatic. CA cannot guarantee members will be notified when the membership term is near expiry.

For expecting or breastfeeding mothers, membership term can be paused for up to eighteen (18) months. Many membership benefits are not advised for expecting or breastfeeding mothers, and as such, the membership can be paused via written notification to [aesthetics@coafs.com](mailto:aesthetics@coafs.com). The membership term will be paused from the date that CA confirms receipt of request to pause. The term can be resumed sooner than eighteen (18) months but not later than.

### **Cancellation Policy**

Cancel anytime. Any refund will be pro-rated based on the remaining months in the membership term, not to include the month in which the cancellation is requested. Cancellation requests cannot and will not be back-dated due to non-use of benefits during the membership term. Future bookings or subscription product orders will not have the membership benefit applied to them, despite time of booking or subscription order start date. Cancellation requests must be submitted in writing to [aesthetics@coafs.com](mailto:aesthetics@coafs.com) and must be confirmed by CA within 7 business days. Cancellation is only valid if confirmed in writing by a CA representative. Refunds will be issued to the card on file or debit/credit card used to purchase the membership. Refunds will be completed within 30 business days of cancellation.
